## **Fulham Football Club's Planning Application for a New Riverside Stand**

The Club has planning permission, but as the stand would be built encroaching into the river, it needs a river works licence from the Port of London Authority. After some delay the PLA has decided to give a licence, but the story does not end there. A licence will depend on the satisfactory negotiation of mitigation measures. Because this huge stand will block the wind on the "Middlesex" side of the river, trees will have to be cut back or felled on the "Surrey" side for boats to sail there instead. These measures still have to be agreed.

## **Lights in the park**

You may have noticed that several of the lamp posts in the park do not work. Sadly this is not just a matter of replacing the bulbs. During the big refurbishment project new wiring to these lamps was installed, but unfortunately it has proved to be faulty. We are pressing the Council to make sure it is repaired before the end of the summer

**Hammersmith Park – the following piece has been sent to us by Virginia Ironside, author, journalist and local resident**

### ***Our Parks are Under Threat***

*When PlayFootball, a commercial football company, applied to Hammersmith Council to rent half of our local Hammersmith Park for 35 years, it was agreed on the basis that it would go ahead if PlayFootball were given planning permission to develop a private club with car park and bar, with 12 very small pitches. The concession to local people would be that two of the*

*five-a-side pitches would be given over to community use, public toilets would be provided and the bar/café could be used by local people.*

*The development means that literally hundreds of local people who currently play on the somewhat derelict tennis courts, basketball pitch and football pitch would be deprived of their amenities. It also would mean that 24 mature trees would be felled, including numerous bushes and flower gardens, and the now defunct children's playground would vanish.*

*There was virtually no local consultation on this and the leaflets put out by PlayFootball were misleading along the lines of "Would you like to see improvements to the sports arena in the park?" Only 57 people attended the public meeting. Many local residents groups were not consulted at all.*

*As a result I instigated a Judicial Review on the grounds that the Council had not done an Environmental Impact Assessment and the Council have agreed to settle and pay my costs (out of OUR money!) A second planning application was made, with an EIA and passed and I am now taking out another Judicial Review on the grounds that it contradicts all the Council's guidelines laid out in the White City Opportunity Area Planning Framework.*

*In the meantime the Leader of the Council has made an emergency unilateral decision to underwrite all PlayFootball's costs if the development fails to go ahead.*

*It is not only Hammersmith Park that is under threat.*

### **Boat Race Day in the Park**

What is usually seen as an enjoyable day out for many residents of Fulham and the wider community was marred by the over commercialisation and corporate takeover of Fielders' Meadow by the sponsor Mellon. Whilst we are wholly in support of the Boat Race we are not in support of the prime viewing area for spectators being used exclusively for the sponsor's guests.

The Boat Race is a very popular event and the local community enjoys the festivities and the rivalry that goes on but this year there have been a number of complaints about the lack of viewing and the access to the River walk being dramatically reduced for the public. Last year the sponsors used the Walled Garden in Fulham Palace for their guests but it was felt that it was not large enough to accommodate increased numbers. This decision was not communicated to the general public (by the usual methods) or the Friends of Bishops Park (consultation) to gauge support or otherwise for such a large area of the park having restricted access.

The erecting and removal of marques, tents, seating etc commenced on 1<sup>st</sup> April and was completed on 9<sup>th</sup> April this is wholly unacceptable for a public park to be out of action for so long. The traffic movements within the park also resulted in some unpleasant words and near incidents during this process which could so easily have been avoided. Time was also then taken to address the extensive damage caused by heavy equipment, marques and fencing by rolling, aerating and hopefully re-seeding the meadow.

We look forward to improved and early consultation with the Council for the 2015 Boat Race.
